Special presentation: Director Dave Pelligrinelli, and Chief Will Ewing, presented one of our long-standing volunteers, Erik Dedijer-Small, with a beautiful statue of an eagle, with an engraved, glass plaque attached to it. The reason for this presentation is as follows: On the evening of April 10 Erik was driving home after work, and he saw a car accident. He turned around to see if he could help. There was a car down the embankment and into a tree. He could hear screaming coming from the car, that was on its' side, and smoke was pouring out of it. With the help of a by-stander, and his heroic bravery, and training, he was able to get down the embankment, and work on getting the trapped women out of the car. The flames were moving closer. They finally got her out and away from the car, as they watched it become engulfed in flames.

1.1 Chief's Report: Runs are up, from last month. Seven new volunteers came in, and filled out applications. During the next few weeks, we will be training on wildland fire attack. We will be in a position to be part of a county wide deployment, should all the conditions be met. That would benefit Seal Rock, by creating a revenue stream, we have not tapped into in years. Engine 62 should be back, from servicing, next week. The long-awaited cleanout was accomplished, on March 30, in Bldg. B and C. There was a great turnout and three trips to the dump. The article about OSHA trying to update the Federal Firefighter Safety Standards needs to be addressed. If it's allowed to pass, it will put small, rural fire departments out of business. We thank Central Coast Fire for the help on a call, because we received three calls, within twenty minutes.

We need to start talking about Earthquake and Sunami preparedness. The full report is included in the Board's packet.

1.2 Volunteer's Report: SLER President, Jeremy Garbina, stated that he bought new furniture, and a TV, for station 62, which was well needed. The funds came from the SLER account. There has been very good turnout, from the volunteers, on calls.
