#### 1.1 Treasurer Rimola:

Motion to transfer \$70,000.00 from General Local Gov't. Investment Pool account, to the General Bank Account, to pay bills/payroll. Paul made the motion, and Mike seconded it. Passed unanimously.

Motion to transfer \$250.00 from the General Fund, to the checking account, at First Security Bank, that pays Paul Highfill. This will cover the July payment. Paul made the motion, and Dave seconded it. Passed unanimously.

Stale checks. Going forward, we will put a stamp on all outgoing checks, that states, "Check void after 6 months".

Treasurer Rimola would like to see future grant money put in a separate account, because it will make it easier for quick books accounting.
